The petitioner, Irene Beulah Seeley, whose race or color is white, being a resident of the State of Oregon, living at Route 1 Street, City of Independence, and having filed a petition for the registration of her birth, and having served a copy thereof upon the district attorney of this county, and more than five days having elapsed since the service and filing of said petition;

And the court having held a hearing upon said petition and being satisfied that the facts stated therein are supported by substantial evidence, hereby finds that petitioner was born at Boston, in the County of Massachusetts, on the 13 day of August, in the year 1895;

That petitioner's original name was Irene Beulah Corliss; that on the 15 day of October, 1914, said name was changed to Irene Beulah Seeley, by marriage;

That petitioner's father was Not Known, of the City of State of , who was born at , and that petitioner's mother was Elizabeth L. Corliss, of the City of Boston, State of Massachusetts, whose maiden name was Elizabeth L. Corliss and who was born at Vermont, on the 12 day of July, 1880.

And the court further finds that petitioner is entitled to a decree of this court requiring the registration of the birth of said petitioner by the State Registrar of Vital Statistics.

IT IS, THEREFORE, hereby ordered and decreed that the birth of said petitioner be registered by the State Registrar of Vital Statistics.
