DECREE FOR  
REGISTRATION OF BIRTH

The petitioner Agnes May Seelye, whose race or color is white, being a resident of the State of Oregon, living at 710 E. Third Street, City of The Dalles, and having filed a petition for the registration of her birth, and having served a copy thereof upon the district attorney of this county, and more than five days having elapsed since the service and filing of said petition;

And the court having held a hearing upon said petition and being satisfied that the facts stated therein are supported by substantial evidence, hereby finds that petitioner was born at Hesper, in the County of Winneshick, State of Iowa, on the 10 day of October, in the year 1876;

Abstract of Supporting Evidence

That petitioner's father was James H. Battey, of the City of Hesper, State of Iowa, who was born at Vermont, on the 10 day of February, 1837, and that petitioner's mother was Lydia Maria Battey, of the City of Hesper, State of Iowa, whose maiden name was Lydia Maria Haines and who was born at Indiana, on the 3 day of February, 1845.

IT IS, THEREFORE, hereby ordered that the birth of said petitioner be registered by the State Registrar of Vital Statistics.
