DNA PROJECT STATUS REPORT

We are making progress on the Seeley DNA project but still need several specific volunteers. We need a volunteer on the Obadiah line for Cornelius, SGS #18. On the Nathaniel line, we need volunteers for Robert, SGS # 6, and Joseph, SGS # 8.

The volunteers must be males from an unbroken line from the original. The test kit contains a swab used to take a sample from the inside of the mouth. The swab is then sent to the lab.

The volunteers are asked to contribute \$100.00 toward the cost of the analysis if possible. The full cost of each sample is \$190.00. For best results, we should have a sample from each line if possible.

The result from one sample has been received others should be following soon.

ANNOUNCEMENTS

ENGLAND 2004

We are so excited about our plans for the trip to England in September, 2004! We hope you are planning to join us for what will be an experience of a lifetime! There are so many things to see in England and the time will be limited so we have chosen to emphasize the time of 1602 AD to 1630 AD when Robert and Obadiah Seeley lived in England. We have met with a travel agent and made the following tentative arrangements:

Sunday, September 12 – All participants will meet at the designated hotel (probably in the area of Hyde Park) for dinner and a participant's meeting.

Monday, September 13 – Leave hotel on chartered bus coach for "The City." This is the area where Robert Seeley lived in 1626 to 1630. We will visit St. Paul's Cathedral, Guildhall, Coleman Street and the Tower of London before leaving for Huntingdonshire and the communities of Great Gransden, (Robert's parents and grandparents had been living here) and Huntingdon (Robert was christened here in 1602.) We hope to visit Hinchinbrooke House, the ancestral home of the Cromwell's (Oliver Cromwell was born in Huntingdon in 1599) and Monagu's (also known as the Earl of Sandwich—the inventor of the Sandwich). We will stay overnight in Huntingdon.

Tuesday, September 14 – Leave for Cambridge and Stratford-on-Avon. William Shakespeare was writing and performing plays in this time period. We will go to a performance at the Royal Shakespearean Theatre. We will stay overnight in Stratford-on-Avon.

Wednesday, September 15 – Leave for Birmingham (possible birthplace of Obadiah Seeley). Visit Bath, a Roman City and continue to Bristol where there is a Seeley Hotel. Stay overnight.

Thursday, September 16 – Visit Stonehenge on the Salisbury Plains, the Isle of Wight (Robert left here in 1630 on his way to the colonies) and stay overnight in Brighton.

Friday, September 17 – Visit Battle, the site of the Battle of Hastings (Family lore says that the Seeley's came from Normandy with William the Conqueror in 1066), Canterbury Cathedral and return to London.

Saturday, September 18 – Meet for breakfast and a concluding meeting.

An accredited tour guide will accompany us and has been asked to add his knowledge of the area and the times to our itinerary. You will have time on your own before and after the tour depending on your own arrangements.

London Diary (Excerpts) edited with permission By LeAnne Seely

My dad, Montell Seely, told me that the national Seeley Genealogical Society was planning a trip to London, England in 2004. When he said that, I perked up my ears and said, "I want to go!" My dad

asked me to share with you my journal entry when I visited Coleman Street.

June, 2002
Coleman Street

No. 7 Coleman Street is where my ancestors, Robert and Mary Seeley lived from 1626 until they emigrated to the colonies in 1630. Coleman Street is only about two blocks long and is off Gresham Street just east of the Guildhall in central London City (The City). A lovely little flowerbed park with benches sits here on the corner of Coleman Street and Basinghall Avenue where I am writing in my journal.

[Two years ago, on a previous trip] I had asked the very helpful clerk [at the Guildhall Library, after searching for their marriage records] if she happened to know in what part of the city St. Stephen's Parish was located and how I might find Coleman Street where my ancestors had lived at No. 7. She said St. Stephen's Parish was right next door to the Guildhall, and Coleman Street was just a couple of streets down. I was astonished! I walked to the street, a small one-way lane and walked up and down it between the tall office buildings. A post office was located at about No. 4 so I bought a postcard and sent it to my father from the street where our ancestors lived.

This morning I went around with a group to the Tower of London where the crown jewels are kept. I had already been there on a previous tour so I passed on paying for another ticket. Alone, I spent a little time at the statue of Caesar by the remains of the original Roman Wall of London, then decided to make my way on foot to the Guildhall to find Coleman Street again. I worked my way over to Gresham Street and found Coleman Street right away. The streets were pretty well empty today because of a bank holiday and everyone being down at St. Paul's Cathedral to watch the procession when the queen goes to the Jubilee Memorial Service there. As I got closer to the Guildhall, I started seeing fancy dressed people, each one with a yellow rose pinned on like a boutonniere, and I realized the Queen's luncheon at the Guildhall was just getting over, to which all invitees had to wear a yellow rose boutonniere to show they had been invited.

Just now as I was writing this, a little girl and her parents walked by, and she was clutching a yellow rose. Her mummy said, "Someone who was invited to lunch with the Queen dropped that and you found it. Now we'll press it and you can keep it as a remembrance." I'm so jealous-I'm tempted to make a pass along all the streets around here to look for a yellow rose I can press as a remembrance!

PROPOSED CHANGES TO THE CONSTITUTION AND BYLAWS

A committee chaired by Katherine Olsen, and consisting of Walter Davis and Ray Hall was appointed by the SGS President, Jim Seeley, to draft proposed revisions to the Constitution and Bylaws of the Society. In the November 2002 and February 2003 SGS Newsletters, proposed changes to the Society's Constitution and Bylaws were published. Comments were received and incorporated. The following annotated version incorporates the proposed revisions to be considered at the 2003 SGS Reunion in Williamsburg, VA, September 2-7, 2003.

Wording enclosed in parentheses indicates proposed deletions; wording underlined indicates proposed additions.

CONSTITUTION OF THE SEELEY GENEALOGICAL SOCIETY

ARTICLE I: Name

- SECTION 1. The name of this organization shall be THE SEELEY GENEALOGICAL SOCIETY, hereinafter referred to as "the Society."
- SECTION 2. The Reverend Garner Osborne is recognized as the founder of the society. Any person who was a member prior to 1965 is a charter member.

ARTICLE II: Objectives

- SECTION 1. The Society will solicit as members, descendants of the Seeley surname of all spellings to include those who by marriage have acquired another surname(s), and anyone who has an interest in genealogy.
- SECTION 2. The Society shall engage in research, study, verification, discussion, collation, publication, dissemination and preservation of Seeley information for the Society, for its members and for posterity. In so far as practical, the Society will respond to all that inquire about Seeley ancestral lines. The Society will receive, hold, and invest appropriate monies, dues, gifts, proceeds from sales, interest, etc. and control and administer any properties for the benefit of the Society. The Society shall publish a periodic newsletter.

- SECTION 3. The Society will establish and maintain associations with societies of other surnames and state and national organizations to encourage interest in genealogy and to benefit therefrom.
- SECTION 4. The Society will pay special recognition to Robert Seeley of England who immigrated to America in *anno domini* 1630; and to Obadiah Seeley, who appeared in the records of Stamford, Connecticut in 1640.
- SECTION 5. The Society will maintain a national Research Center, co-located with the Seelye Mansion in Abilene, Kansas. The Research Center will collect family and archival records for research by the membership and members of the general public.

ARTICLE III: Membership and Dues

- SECTION 1. There shall be three classes of membership in The Society.
- (1) Charter: Persons who participated in founding and administration of The Society prior to 1965.
- (2) Individual, Library or Society
- (3) Lifetime
- Charter, Individual and Lifetime memberships shall apply to a member and spouse.
- SECTION 2. Dues shall be specified in the by-laws.

ARTICLE IV: Officers

- SECTION 1. The elected officers of the Society¹ shall be a President, First Vice-president (for Membership), Second Vice-president, Secretary, Treasurer, Chief Genealogist, and three Directors elected from the general membership.

The President shall appoint an Ancestral Files Chairman, a Membership

1. All elected and appointed officers of the Society may be of either gender without exception. Throughout this document the use of the masculine pronoun should be considered in the classical sense to apply to both male and female genders.

Chairman, a Publications Editor, a Judge Advocate, and a Director for the National Research Center.

- SECTION 2. Officers and Directors of the Society shall be elected for a term of two years. The election is to take place at the national reunion. Officers and members in good standing are eligible to vote. A quorum of 25 members is required to elect.

- SECTION 3. The officers and directors term of service shall begin on the first of the month following the election or re-election of officers at the national reunion (held every second year).

- SECTION 4. No member shall hold more than one office at a time, except for short times resulting from succession to office as provided for in Article IV, Section 5 below.

- SECTION 5. In the event of the resignation or incapacity of any officer, except the President or a Vice President, the vacancy will be filled by a majority vote of the remaining elected officers. For the unexpired term, of the President and/or a Vice-president, (a successor will be appointed) succession will be automatic from the remaining elected officers in the order shown in Article IV, Section 1 above, (to serve in an acting capacity until the next reunion) exclusive of the Treasurer.

- SECTION 6. The elected officers and directors shall constitute an Executive Board.

- SECTION 7. If there is more than one nominee for any office, election shall be by secret ballot, and a majority of those voting shall elect.

ARTICLE V: Meetings

- SECTION 1. The membership shall meet at least every two years, as specified in the by-laws. Business of the Society may be conducted if there is a quorum present at the reunion.

- SECTION 2. The officers and executive board shall meet as specified in the by-laws and serve without monetary compensation.

- SECTION 3. The order of business at all meetings will be governed by Roberts Rules of

Order, Revised. The President may appoint a Parliamentarian, who will serve at the pleasure of the president.

SECTION 4. To conduct business of the Society, a quorum of 25 members will be required. Five elected officers constitute a quorum of the Executive Board.

BY-LAWS OF THE SEELEY GENEALOGICAL SOCIETY

ARTICLE I: Membership and Dues

SECTION 1. Annual dues for charter, individual and library membership shall be established by the membership at a regular reunion. The fiscal period is to coincide with the term of the officers. Dues are to be paid to the Membership Chairman, who will issue a membership card, and forward the dues to the Treasurer. A change in dues must be approved by the membership at a reunion. A three-fifths vote of members attending in favor is required to increase the dues, subject to a quorum requirement. Dues for life membership are established at one hundred United States dollars (US\$100) for a member and spouse.

SECTION 2. Membership will be awarded as specified in Article II, section 1 of the constitution.

SECTION 3. Membership may be refused or suspended by a three-fifths vote of the Executive Board to anyone or any organization, whose interests conflict with the purpose(s) of The Society.

ARTICLE II: Meetings

SECTION 1. The President, with the approval of the Executive Board, shall call meetings of the Board and the general membership subject to the minimum requirements of the Article V, section 1 and 2 of the constitution.

SECTION 2. It is recommended that the president call a meeting of the Executive Board each year in the month of August or at a mutually agreed upon time. The Society recognizes the geographical dispersion of the officers and directors. The President may present to and solicit from officers and directors

public mail responses to questions, programs and reports necessary for the administration of The Society. These are to be reported to the membership in the newsletter. The in-person meeting of officers and directors is encouraged when it is practical.

SECTION 3. Six (6) of the officers and board of directors may call a special meeting of the officers and directors for consideration of issues. A special officers and directors meeting may also be called by twenty-five members of the Society by signed petition, at no expense to the Society. Quorum requirements will apply.

ARTICLE III: Duties of (Elected) Officers

SECTION 1. The President shall be the chief executive officer of the Society and preside at all meetings. He shall be a member of all committees except the nominating and auditing committees. He shall be authorized to appoint Assistant Genealogist positions. The President is authorized to approve disbursement of reasonable fund amounts from the Treasurer's account(s) for the routine operation of the Society business, to carry on correspondence and to publish the newsletters. The President shall serve as the chairperson of the committee to organize the membership meeting conducted per Article V, Section 1 of the Constitution.

SECTION 2. If the President determines that an elected officer or director is not performing the duties for which elected, he may request the Executive Board remove the member. Such removal will require a three-fifths vote of eligible Executive Board members.

SECTION 3. The First Vice-president shall (have charge of membership, promotion for the Society, act on behalf of the President when required and assume the presidency if the office becomes vacant.) perform duties assigned by the President, preside and perform all duties necessary in the absence of the President and assume the Presidency if the office becomes vacant.

SECTION 4. The Second Vice-president shall perform duties assigned by the President, preside and perform all duties necessary in the absence of the President and First Vice-president.

SECTION 5. The Secretary shall record and preserve the minutes of the meetings of the

executive board and of the reunions. The Secretary will perform other administrative duties as assigned by the President.

SECTION 6. The Treasurer shall safeguard funds and maintain all accounts in the name of The Seeley Genealogical Society. He shall be responsible for adequate financial records. When the executive board shall determine bonding is required, this will be done at the expense of the Society. If investment of funds of the Society is made, approval of the Executive Board is required.

SECTION 7. The Chief Genealogist shall have custody of the genealogical files of the Society and maintain such other files necessary for the performance of his duties. He will safeguard them from common hazards. The duties are those generally accepted as responsibilities of a genealogist. He will be assisted by genealogists appointed by the President as authorized in Article III, section 1 of the by-laws. He shall comply with the requirements of Article II, section 2 of the constitution. He shall also work closely with the Director of the national Research Center to assure that all Society records are copied and/or archived at the Center for researchers' use.

SECTION 8. The Publications Editor shall be responsible for the organization, printing and mailing of the quarterly newsletter. The newsletter shall include inquiries submitted to the Society for general membership response. The closest liaison must be maintained with the Membership Chairman, and the Chief Genealogist to perform these duties.

SECTION 9. The Judge Advocate may be a member of the legal profession; but may only be one who can secure information, if needed, and advise when appropriate. He or she may act as parliamentarian at meetings, if appointed by the President.

SECTION 10. Directors: The three Directors shall serve as representatives of the general membership. They may be assigned duties by the President to assist in the administration of the Society.

SECTION 11. Ancestral Files Chairman: The Ancestral Files Chairman shall be responsible for maintaining a computerized database of all ancestral files submitted by members of the Society. He shall also be responsible for responding to inquiries to the Society regarding established lineage.

SECTION 12. Research Center Director: The Research Center Director shall be responsi-

ble for maintaining the National Research Center in Abilene, Kansas, as a resource to Society members and members of the General Public. He shall act as an advisor to the President and to the Chief Genealogist.

SECTION 13. The immediate past President shall be an ex-officio member of the board of directors and committees in a non-voting advisory capacity.

SECTION 14. Membership Chairperson: The Membership Chairperson shall be responsible for the promotion of the Society membership, maintenance of membership rolls, and collection and forwarding of dues to the Treasurer. He shall be appointed by the President from the membership exclusive of the Treasurer.

SECTION 15. The President, with the approval of the Executive Board, may establish other positions and collateral duties not named elsewhere.

ARTICLE IV: Committees

SECTION 1. Committees. The president shall appoint necessary standing and ad hoc committees and require reports from them.

SECTION 2. Nominating committee. The president shall appoint a nominating committee of at least two (2) members one year in advance of the national reunion. The nominating committee shall ascertain that all candidates nominated will be willing to serve if elected. The election shall be as provided in Article IV, section 2 and section 3 of the Constitution. Nominations may be made from the floor for all offices with the consent of the nominee.

SECTION 3. Auditing committee. The president shall appoint an auditing committee of not less than two (2) members, to examine the financial records of the Society, once every two years, or oftener if required by the executive board. The results will be in writing and published in the newsletter.

ARTICLE V: Amendments

SECTION 1. The Constitution or By-laws of the Society may be amended by a three-fifths majority of members, provided that a quorum is present, at an authorized reunion. Any amendment proposal must be printed and submitted to the membership in the newsletter at least three months prior to the reunion.

SGS DATABASE RENAMED SEELEY ANCESTOR FILE

On page 2 of this Newsletter, you will see a change in title for John R. Seely. In 1983 John, a former Director of SGS, undertook the enormous task of putting all the material SGS possessed on Seeley descendants into a database that would allow him to index names and relationships and accommodate the various differences in spelling of the surname. This file he appropriately named the ANCESTOR FILE. From now on, this Newsletter will refer to the SGS Database as the "SEELEY ANCESTOR FILE."

What is it? The SEELEY ANCESTOR FILE contains names of SEELEY descendants (of all spellings of the surname) compiled from the data sheets, computer files, birth, marriage, and death records that have been sent to John over the past 20 years. He started out by indexing about 25 notebooks that SGS President Robert Cox had copied from SGS Member Esther Houtz Walter. Since then, John has added to the SEELEY ANCESTOR FILE information he obtained from *The Seelys of New Brunswick*, Annie Cilley's book on the Isles of Shoals Cilleys, Helen Ault's Obadiah Seely lineage books, and Elaine Wallace's compilation. It does not contain specific information from Betty Allen's book, but Terry Tietjens has a copy of that at the Seelye Research Center. The SEELEY ANCESTOR FILE when used in conjunction with the three SGS publications listing the first seven generations of descendants of Robert Seeley and Obadiah Seeley (see page 4 of this Newsletter) has proven to be a valuable genealogical research resource.

John produced four index lists from his File Pro database to help attendees search for connections to ancestors during the SGS Reunion held in Saint John, New Brunswick, Canada several years ago. These four lists were bound in blue books and are still kept at the Seelye Research Center in Abilene, KS, where they have been frequently consulted by visiting researchers. They have proven very useful to many SGS Members and have been updated for use at the 2003 Reunion. The names of the four listings are:

- SEELEY Children, alphabetical list,
- SEELEY Children, listed by Mother's Index,
- NON-SEELEY Children, alphabetical list, and
- NON-SEELEY Children, listed by SEELEY Mother.

John Seely has been a very active member of the SGS Query Team now headed up by our new Query Editor, Linda Crocker. John is planning a presentation at the next SGS Reunion on why he developed the ANCESTOR FILE INDEX. He will provide further details to help make it easier for attendees to use the index in the future.

Digital Copies of Old Family Photos

A digital camera can be used to reproduce old photographs, and offers better flexibility, portability, and resolution than most scanners. My camera has a zoom lens, a preview screen, and a "macro" mode for extreme close-ups, so photos can be laid flat and copied quickly without removing them from albums or frames. Snapshots as small as 2" x 3" are reproduced with remarkable fidelity. While home for the holidays, I photographed over a hundred old photos from a family album in about an hour. The photos were later downloaded to a computer with a CD burner,

Then try adding an "s" to the end of the surname. For example, I could not locate my Egger (E260) and Riggle (R240) families. It turned out they were enumerated and Soundexed as Eggers (E262) and Riggles (R242). That little "s" made a big difference. Lori

SGS Member Dorothy H. Vining sent SGS a letter on 17 Jan 2003 that clarified Eber Harger's place of burial. Dorothy states she is a g-g-g-granddaughter of Mary/Polly Seeley and Eber Harger. Dorothy visited the graves of Eber and Mary/Polly Harger at the North Farmington Cemetery in Farmington, MI. Dorothy also enclosed pages from the index of Cemeteries of Oakland County, MI that listed Eber Harger and Mary/Seeley Harger's death dates. The question remains, was the North Farmington Cemetery always in Oakland County, or was that area once in Genesee County?

No response has been received regarding the Eber Harger who m. 2 Apr 1843 Eliza Taylor.

Update to Query 0205-3 **Re Benjamin Seeley**

They were parents to 15 children: Caleb, Alexander, Alfred, Aletta, Emily J., Sarah C., Elizabeth Jane, Frances, Millicent, Lewis, Adaline, Ellen M., and Harrison and an unnamed son and daughter. Cheryl is descended from Caleb.

The SGS Generations One Through Five show Israel (SGS #484) to be a son of Bazaleel Seeley (#186). J. Kelsey Jones places him in Nathaniel's family based on an account in the Towanda, PA Reporter Journal of 4 June 1885. An account in the same paper on 14 May 1885 places Benjamin as a son of Israel Seeley, although he does not appear in Israel's family in the SGS Sixth Generation volume. Please contact J. Kelsey Jones if you want further information on these families. Please contact the Query Editor if you can prove or disprove these family alignments.
